Non-affiliates Companies not related by common ownership or control. They can be financial and nonfinancompanies. Non-affiliates we share with can include mortgage companies, banks, insurance and nonprofit organizations.							
Joint marketing A formal agreement between nonaffiliated financial companies that together market financial or services to you. Our joint marketing partners include mortgage lenders, credit card companies settlement providers, and other financial services companies.							

Other important information

California: If you are a resident of California, you are permitted to limit our disclosure of your non-public personal information to (i) our affiliates and (ii) non-affiliated financial institutions with which we have a joint marketing agreement.
